Hunter & Jumper points are awarded to the Horse, so the Owner of the Horse must be a BCHJA Member. Note: The information that is required on this membership form will only be used for the Association to build its membership.

STEP 1:

Individual – This is an Amateur or Junior Rider (junior is determined by Birth Date as defined in Equine Canada Rules)

Trainer/Pro – This is a Person that is considered to earn money from the industry in either training horses/people or riding professionally

Company/Barn Name: If your company or barn owns horses that will be shown and collect BCHJA points then the Company/Barn must have a membership number.

Associate – This is for a Parent/Guardian/Spouse or anyone who would like to part of the organization and support the organization and its programs.

STEP 2:

Last Name/First Name: Please make sure this is the same name, as you would list on the competition entry form.

Company/Barn Name: This is only if you need a membership in this name and you have ticked the “Company/Barn Name” box – otherwise leave BLANK.

Address: complete info as required – again, please make sure it matches to your competition entry form.

Phone Number: Please provide the best number of contact or to leave a message.

City/Prov/Postal Code: Please make sure this is legible

Birthdate: Mandatory field to determine “Junior” designation

E-mail Address: Mandatory field. If you do not have your own email address, you may identify the address of a designate who has agreed to have your printable registration information and BCHJA correspondence sent to them.

STEP 3:

Trainer Name: Please list only 1 trainer and if they have a Barn Name you may list this as well. Please note that to collect BCHJA points your trainer must also have a BCHJA number starting in 2008 (Refer to AGM minutes Jan 7/08). By putting your trainers name down, we can cross reference to ensure that your trainer is a member, so that your points do not get missed. If you do not use a trainer on a regular basis, then note “Self” in the Trainer Name section.
